Full Paper Submission Guidelines

- Manuscripts must be in MS Word format.
- Articles should be typed in Times New Roman, font size 12, double-spaced.
- Ensure the language is professional English, adhering to grammatical and scientific standards.
- Submit manuscripts via email to physioconnectscientific@gmail.com.

Formatting Guidelines:

- **Title Page:**
 - Include the title of the paper, authors' full names, qualifications, affiliations, and contact details.
 - Provide the corresponding author's email and phone number.
- **Abstract:**
 - Word limit: 250 words.
 - Structured format for original articles (Background, Aim, Methods, Results, Conclusion).
- **Keywords:**
 - Include 4-6 keywords relevant to the study.
- **Main Text:**
 - Use the IMRAD structure: Introduction, Methods, Results, and Discussion.
 - Include a separate Conclusion section.
 - The maximum number of words including all subsections should be 2500-3000 words.
- **Figures and Tables:**
 - Numbered sequentially and referenced in the text.
 - Provide high-resolution images.
 - Include legends for all figures and tables.
- **References:**
 - Follow Vancouver Style.
 - Provide DOI or URL for online references where applicable.

Ethical Compliance:

- Studies involving human participants must have Institutional Ethical Committee approval and clinical trial registry if applicable.
- Provide a statement of informed consent where applicable.
- Clearly disclose any conflicts of interest.

Specific Requirements for Original Articles:

- Word Count: Up to 3000 words (excluding references, tables, and figures).
- Figures and Tables: Maximum of 5.
- References: Limit to 25-30 citations.
- Clearly define inclusion and exclusion criteria in the Methods section.

Peer Review Process:

- Articles undergo a double-blind peer review.
- Authors should allow 9-12 weeks for communication on acceptance, resubmission, or rejection.
- Plagiarism report with no sub checks (words or percentage) needs to be submitted along with manuscript.

Article Processing Charges (APC):

- Authors are required to bear the processing charges upon acceptance of the manuscript.

Ethical and Legal Considerations:

- Authors must agree to the automatic transfer of copyright to the publisher upon acceptance.
- Manuscripts should not be published elsewhere without the publisher's consent.

Abstract Submission Guidelines

1. Abstract must be written in ENGLISH.
2. Each Submission must be made electronically on google Form (link) and abstract to be uploaded on drive link given on the form in word format only.
3. The submitting author must be presenting author as the correspondence will be with the submitting author.
4. Each presenter can correspond and present only 1 paper. They can be named on other papers as co-author but as presenting author only on one paper.
5. The certificate will be given to presenting author. Only 2 co-authors can get the certificate provided they are registered for the conference.
6. The body of the abstract should limit to 250-300 words.
7. Abstract shall be submitted under following headings as applicable for type of paper:

For experimental, cross sectional, co relational studies & case series

Title: Provide the study title, author names, and affiliation details.

Background: Explain the study's relevance to physiotherapy, highlighting its impact on practice, management, education, policy, or the **evidence base in the field**.

Purpose: Outline the study's primary and secondary objectives to establish its focus and goals.

Participants: Detail the participant group, including the number, characteristics, and selection criteria for study inclusion.

Methods: Describe the methodological approach and specify data collection techniques used to ensure rigor and accuracy.

Results: Summarize the type of data analysis (qualitative or quantitative) performed, and highlight the main findings from the data interpretation.

Conclusion: Provide a concise summary of key outcomes and suggest directions for future research or practical applications.

Implications: Describe the study's implications for physiotherapy practice, management, education, or policy, emphasizing potential real-world impact.

Keywords: Identify up to three keywords that reflect the core focus of your study beyond the main topic.

References: List all references in Harvard style to maintain academic consistency.

Platform Presentation

For Single Case study & Systematic/literature/narrative review

Title: Title of the review, including author names and affiliation.

Background: Explain the scope and relevance of the topic to physiotherapy practice, education, management, or policy. Include any gaps in the evidence that prompted this review.

Purpose: State the main objective(s) of the review, such as summarizing current evidence, identifying trends, or clarifying inconsistencies.

Inclusion Criteria: Define the criteria used for selecting studies, including types of studies, population characteristics, interventions, outcomes, and publication dates.

Methods:

Search Strategy: Outline the databases searched and keywords or search terms used.

Data Extraction: Describe the process of data extraction and selection of relevant studies.

Data Analysis: Describe how the studies were analyzed (e.g., thematic analysis for qualitative data or meta-analysis for quantitative data). Summarize main trends, findings, or themes identified across studies.

Results: Present a summary of the key findings and patterns observed in the literature, including any noteworthy gaps or consistencies in evidence.

Conclusion: Provide a concise summary of the review's conclusions, including the implications of the findings for practice and suggestions for future research.

Implications: Discuss the potential applications for physiotherapy practice, management, education, or policy.

Keywords: Select up to 3 keywords that represent the main focus of the review.

References: Format all references in Harvard style.

8. All presentations must be described original work to which all the authors listed had made a significant contribution.

9. Presenting author of the selected abstract need to be registered to the conference before 31st Jan 2026. Failing which the abstract will be withdrawn

All submitted abstract will go through blinded peer review process carried out by expert reviewers and might come back for revisions.

All decisions of the programme committee will be final.

Last Extended date of Full Article submission : 15th Feb 2026

Guidelines for making Presentation

Presentation Format:

- **Software:** Use Microsoft PowerPoint for preparing the presentation.
- **Layout:** Set slides to Landscape orientation.

Presentation Structure:

- **a. Title Slide:** Include the title and abstract number (will be given after acceptance of abstract) only. The presentation must be kept completely blinded.
- **c. Background and Objectives (3-4 slides):** Provide a concise overview of the research problem, the need for the study, and its objectives.
- **d. Methods (6-7 slides):** Detail the study design, setting, participants (sample selection/allocation, source, size, inclusion criteria), outcome measures, procedure, and data analysis plan.
- **e. Results (3-5 slides):** Present key findings with appropriate statistics and visualizations.
- **f. Discussion (2-3 slides):** Summarize key insights and interpretation of results.
- **g. Conclusion (1 slide):** State the study's main conclusions based on findings.

Presentation Timing:

- **Duration:** The presentation should be a maximum of 7 minutes.
- **Q&A:** There will be an additional 2 minutes for questions from moderators/audience. Plan your slide content accordingly.

Poster Presentation Guidelines

Poster Size and Format:

Posters should be prepared in ISO A0 size, landscape orientation, measuring 33.1 inches (height) x 46.8 inches (width). A single large sheet is required; smaller sheets (e.g., A4 or Letter size) are not permitted. The display area will be inspected each day before the conference opens.

Mounting Instructions:

Use only the Velcro tape provided at the poster desk to mount your poster on the display board.

Security Notice:

While every effort will be made to safeguard the poster area, security cannot be guaranteed. Ensure your poster is not your only copy of your work.

Display and Removal Times:

Posters must be displayed by 8:30 am and removed by 4:00 pm on same day. Authors are responsible for both putting up and taking down their posters.

Punctuality:

Please be mindful of display and session timing and adhere to the schedule.

Poster Session Attendance:

Authors are required to be present at their posters for the full 45-minute session to engage with delegates and answer questions.

The poster presentation will be by the UG students only.

Poster making guidelines:

1. Title and Authors

Title: Display the title prominently at the top of the poster.

Authorship Requirements:

The presenting author must be either the first or second author on the poster.

A maximum of four authors is permitted per poster.

Content Specifications:

The poster should display only the study title and the assigned abstract number provided upon acceptance.

Posters must not include any identification details of the presenting author, institution, or college. Posters with such identifying marks will be disqualified from presentation.

2. Introduction/Background

- Briefly outline the context and importance of your research.
- State the problem, research gap, or need that the study addresses.

3. Objectives

- Clearly state the primary and, if applicable, secondary objectives of your study.

Poster Presentation Guidelines

4. Methods

- Study Design: Specify the type of study (e.g., randomized controlled trial, observational study, case study).
- Participants: Describe sample size, key characteristics, and inclusion/exclusion criteria.
- Procedure: Summarize the steps taken, interventions used, or conditions studied.
- Data Collection & Analysis: Briefly describe how data were collected and analyzed.

5. Results

- Present key findings with supporting statistics and visuals (e.g., graphs, tables, or images).
- Use bullet points for clarity and ensure visuals are easy to interpret.
- Highlight significant findings that directly relate to your study objectives.

6. Discussion

- Interpret your results, focusing on the meaning and implications.
- Address any limitations of the study and suggest possible improvements or considerations.

7. Conclusion

- Summarize the main findings and their relevance.

8. Implications for Practice

- Briefly outline how your findings could influence clinical practice, policy, education, or further research.

9. References

- Include key references using Harvard style, by providing a QR code for an extended reference list.
